# "Connecting People... Creating Independence"

### What is IHSS?



- Provides personal care and domestic services to persons who are aged, blind or disabled so they can remain in their own homes.
- Social Worker makes a home visit and performs an assessment of the Consumer's needs.
- Financial eligibility determined by county.
- Recipient hires a provider(s) to perform caregiver assistance based on assessment hours authorized by the Social Worker.

#### Our Mission

 We aim to empower IHSS Recipients of Marin County to remain independent and safe by supplying quality, in-home Care Providers for whom we select and support.

### Our Vision

We envision a world where all IHSS Recipients of Marin County remain independent and safe at home.

### What we do:

- · Recruit and screen potential Providers.
- Maintain a computer referral list (Registry) of available Providers to assist IHSS Consumers
- · Provide training to Providers and Recipients
- · Negotiates with Union for wages, benefits and other conditions of employment.
- · Advocates for IHSS program recipients and providers.
- Assists recipients navigate the IHSS system (including the EVV Electronic Visit Verification)



· Help our IHSS care providers reach self-sufficiency.

## Personal Assistance Registry


- MCIL has been running a Personal Assistant Services (PAS) registry as part of our core services for over 40 years.
- The PAS program serves more consumers than any other department in our office.
- The registry matches individuals with carefully screened and experienced personal assistants (PAs) who assist individuals with activities of daily living.
- The consumer is the employer of record and pays the PA directly out of pocket or through a payroll service.


# Emerging Needs.



70% of adults over the age of 65 will need a caregiver.

(Approximately 14% of our country's population is over 65, or roughly 4.4 million Americans.)

# Emerging Needs.



In the Bay Area alone that accounts for over 150,000 seniors.

### U.S. Home Care Worker Facts

- The home care workforce has more than doubled in size over the past 10 years from 800,000 to 1.6 million.
- Nearly 9 in 10 home care workers are women, their median age is 45.
- While people of color make up one third of the total US workforce, they comprise more than half of all home care workers.
- Over one quarter of home care workers were born outside the US.


### U.S. Home Care Worker Facts

- More than half of home care workers have completed no formal education beyond high school.
- 73% of home care workers are below 300% of the federal poverty level. The national median wage is approximately \$10.49 an hour.
- From 2014 to 2024 home car workers are projected to add more jobs than any other occupation with an additional 633,100 new jobs anticipated.



# Family/Friends Caregivers

- A caregiver—sometimes called an *informal caregiver*—is an unpaid individual (for example, a spouse, partner, family member, friend, or neighbor) involved in assisting others with activities of daily living and/or medical tasks.
- More than 1 in 6 Americans working full-time or part-time report assisting with the care of an elderly or disabled family member, relative, or friend.

# Need for Caregiving


- By 2029, 14.4 million seniors are estimated to fall into a "middle market" gap
  - Unable to afford assisted and independent living
  - Too wealthy to qualify for Medicaid/MediCal
  - Want to (have to) stay at home
  - Would like not to spend down their assets
  - May/may not be able to afford in-home care providers
  - Will depend on family and friends for care

# **Economics of Family Caregiving**

The value of the services family caregivers provide for "free," when caring for older adults, is estimated to be \$375 billion a year. That is almost **twice as much** as is actually spent on homecare and nursing home services combined (\$158 billion).


