Ache Lytle, Director of Organizational Development, Inclusion, and Culture, On Lok



Aché Lytle has had extensive work experience in various leadership and development roles. They worked at On Lok for three years, starting as a Leadership Development Manager in 2019 and later becoming the Manager of Leadership and Diversity, Equity, and Inclusion. Their most recent role at On Lok was as the Director of Organizational Development, Culture, and Inclusion. Prior to On Lok, they founded Leading Beyond Boundaries in 2003, where they organized international trainings, conferences, and joint ventures aimed at raising awareness of racial, social, and health disparities. They also worked as a Chief Resilience

Officer at In Their Power, a program for Women of Color Leaders, and as a Leadership and Health Care Trainer & Content Developer at JVS - San Francisco. Additionally, they served as an Educational Consultant at the University of California, Berkeley, where they managed academic programs and ensured compliance with regulations and policies. Aché Lytle holds a Bachelor's degree in political economics from the University of California, Berkeley.

Ash Kalra, California State Assemblymember, District 25



Assemblymember Kalra represents California's 25th Assembly District, which encompasses the majority of San Jose, including downtown and open space areas in southeast Santa Clara County. He was first elected in 2016, becoming the first Indian American to serve in the California Legislature in state history, and was re-elected to his fourth term in 2022. Assemblymember Kalra is the Chair of the Committee on Labor and Employment and serves as a member on the Housing and Community Development, Judiciary, Transportation, and Water, Parks, and Wildlife committees. In the State Assembly, he has authored

successful legislation promoting secure and peaceful communities for all residents, including protecting and preserving civil rights and civil liberties, and has dedicated his tenure in public service to equity and social justice issues. He previously served on the San Jose City Council for eight years and was formerly a Deputy Public Defender for Santa Clara County for 11 years, representing clients in dozens of felony jury trials. As a public defender, he represented indigent clients in both felony and misdemeanor matters, and a majority of his time was spent in drug treatment court where clients were given the opportunity to complete a rehabilitation program and turn their lives around.

Bradley Davis, Chancellor, West Valley-Mission College District



Bradley Davis has more than two decades of senior administrative experience in public higher education in California. He is currently in his fourth year as the chancellor of the West Valley-Mission Community College District in Santa Clara County. As chancellor, he oversees a multi-college district that encompasses both West Valley College in Saratoga and Mission College in Santa Clara. At WVM, Mr. Davis serves over 16,000 students, partners with more than 1,400 employees represented by four labor unions, manages the district's basic-aid financing structure and \$225M annual budget, and oversees the district's billion-

dollar facilities construction bond. Chancellor Davis received numerous awards and recognitions for his contributions to the social and cultural life of the local community from Saratoga Rotary, Kiwanis International, The United States Navy, West Valley Community Services, Saratoga Area Senior Coordinating Council, the League of Women Voters, and others. Mr. Davis is a frequently invited presenter on a wide variety of topics for public and state agencies including community relations, organizational development and management, strategic planning, bond and facilities development, fundraising, and intercollegiate athletics. Mr. Davis holds a juris doctorate from Syracuse University's College of Law and earned a bachelor's degree in psychology from Gannon University where he lettered in two NCAA Division II sports, baseball, and basketball. He lives in Foster City with his wife Angie and their two children. In his very little spare time, he enjoys playing and collecting vintage electric guitars, coaching youth sports, and traveling with his family.

Dave Cortese, California State Senator, District 15



Senator Dave Cortese was elected in November of 2020 to represent State Senate District 15 which encompasses much of Santa Clara County in the heart of Silicon Valley. Along with his accomplished career as an attorney and business owner, the Senator previously served on the Santa Clara County Board of Supervisors for over a decade, with four years as Board President, on the San Jose City Council for eight years, including two years as Vice Mayor, and as a trustee for the East Side Union High School District for eight years. He grew up in San Jose as part of a family that has been active in civic, cultural,

and business activities for generations. During his nearly three decades in public service, Dave has brought the community together to address and reduce homelessness, combat climate change, expand public transit options, reform the Santa Clara County's jail custody operations, and fight for the rights of immigrants.

David Lindeman, PhD, Executive Director, CITRIS Health, CITRIS and the Banatao Institute



Dr. Lindeman has worked in the fields of health and long-term care for over 40 years as a health services researcher and gerontologist, conducting research related to telehealth, health care technology, chronic disease management, healthy aging, disabilities, dementia, community-based and residential services, health care workforce, and family caregiving. Dr. Lindeman's current focus is working with researchers, entrepreneurs and investors on the incubation, start-up, and scaling of technology-enabled health care solutions, including initiatives that address critical health care challenges through machine intelligence

(Generative AI and Large Language Models), telehealth, mobile/cloud, sensors/IoT, robotics, VR/AR, and assistive technologies. These technology-enabled solutions cover a continuum of health care issues, ranging from wellness to complex chronic conditions and precision health, with an emphasis on global applications. Dr. Lindeman serves as an advisor to foundations, government agencies, start-ups, businesses, and venture firms. Dr. Lindeman previously served as the founding Director of the Mather LifeWays Institute on Aging; Associate Professor of Health Policy at the Rush Institute for Healthy Aging, Rush University Medical Center; and Co-Director of the UC Davis Alzheimer's Disease Center. Dr. Lindeman received his PhD and MSW from the University of California, Berkeley.

Diana Miller, Retired, Project Manager, Seniors' Agenda, Santa Clara County Department of Aging and Adult Services



Diana's strategic vision--to share knowledge of the program's benefits to cities--resulted in WHO's recognition that Santa Clara as the first county in the United States to have each of its fifteen cities declared "age-friendly." Nadine Roberts Cornish founded The Caregiver's Guardian (TCG) in 2009. TCG is an organization that provides support services to meet the needs of family caregivers. Nadine's journey into caregiving began when she became a caregiver for her mother, a role she held for 15 years. This personal experience led her to dedicate her life's work to caregiving through consulting, education, and coaching. Over the past 14 years, through TCG, Nadine has been an advocate for family caregivers across the United States. She understands that caregiving is a family affair and most recently recognizes the often

overlooked role of youth caregivers within all of our systems. Nadine has expanded her efforts by launching a nonprofit organization called TCG Education & Advocacy, where she serves as the Executive Director. This organization focuses on raising awareness about caregiving issues and advocating for youth and family caregivers. One of Nadine's notable achievements is the development and implementation of the C.A.R.E.E. program (Caregiver Advocacy & Resources for

He also plays a key role in disaster preparedness and response. Steve's prior work experience includes 10 years as Labor Program Director at United Way Silicon Valley, where he directed volunteers and oversaw fundraising campaigns in both public and private sector union workplaces. It also includes nearly six years as Political Director for the Service Employees International Union where he coordinated relationships between public sector unions, elected officials, and legislative offices to meet mutual goals and interests regarding legislation and other political matters. A long-time community activist and organizer best known for his work to prevent domestic violence and homelessness, Steve was honored in 2009 by His Holiness the Dalai Lama as one of 49 individuals from around the world as an "Unsung Hero of Compassion," and in 2012 by the National Association of Social Workers as recipient of its "Stand Up for Others" Award. Steve earned a bachelor's degree in fine arts from Southern Oregon University in 1972. He has served as a board member of several organizations, including Recovery Café San Jose, a support organization for the homeless; vice chair of Building Peaceful Families, an organization dedicated to improving the health, safety, and well-being of children; Loaves and Fishes; Marines Toys for Tots Santa Clara County Chapter; and Second Harvest Food Bank.

Susan DeMarois, Director, California Department of Aging



Susan DeMarois was appointed by Governor Gavin Newsom to serve as Director of the California Department of Aging effective November 1, 2021. As Director, Ms. DeMarois is committed to stakeholder engagement, equity and inclusion; and system transformation to prepare our state for the year 2030 when one in four Californians will be aged 60 or older. Prior to joining CDA, Director DeMarois led public policy and advocacy for the national Alzheimer's Association in California, serving as the nonprofit organization's registered lobbyist in Sacramento where she advocated for legislative, budget,

and regulatory changes at the state Capitol. The organization led the effort to enact the first dementia early detection initiative in the nation focused on the Medicaid population: SB 48 (Limón) signed into law by Governor Newsom. Before working for the Alzheimer's Association, Ms. DeMarois led government and community relations for the UC Davis Health System where she gained deep health policy and clinical workforce experience. Early in her career, she worked for LeadingAge California, the professional trade association representing not-for-profit housing, residential care and skilled nursing providers. A graduate of CSU Chico, Director DeMarois started her career working for the U.S. Congress and California State Assembly. She is a proud mom to two adult daughters, and draws inspiration for her work from her own mom's experience with dementia.
